

Kvit Seas

Vitamin A, D₃, B₁, B₂, B₆, C, E, Nicotinamide & Cod Liver Oil

Composition:

Each 5 ml syrup contains Vitamin A (as Vitamin-A Propionate BP) 2000 IU, Vitamin D₃ (as Cholecalciferol BP) 200 IU, Vitamin B₁ (as Thiamine Hydrochloride BP) 0.7 mg, Vitamin B₂ (as Riboflavin Sodium Phosphate BP) 0.85 mg, Vitamin B₆ (as Pyridoxine Hydrochloride BP) 0.35 mg, Nicotinamide BP 9 mg, Vitamin C (as Ascorbic Acid BP) 17.5 mg, Vitamin E (as Alpha Tocopherol Acetate BP) 1.5 mg and Cod Liver Oil BP 100 mg.

Description:

Kvit Seas contains 8 essential vitamins with Cod Liver Oil. Kvit Seas provides extra protection for the children. Kvit Seas ensures for getting enough vitamins to children that help them to grow up strong & healthy. Cod Liver Oil contains Vitamin A, Vitamin D₃, EPA & DHA. Vitamin A is essential for the immune system, bone growth, night vision, cellular growth, testicular and ovarian function. Vitamin D₃ is essential for the absorption and utilization of calcium, which is also required for skeletal growth. EPA and DHA—the two Omega-3 fatty acids, which are converted in the body to produce prostaglandins that affect a wide variety of physiological processes due to their modulating effect on the action of hormones. Omega-fatty acids relieve the symptoms of osteoarthritis & rheumatoid arthritis, enhance immune function and promote healthy blood circulation. It is thought that EPA and DHA may reduce the risk of coronary heart diseases. DHA seems essential for normal brain development in unborn babies.

Indications:

Kvit Seas is indicated in vitamin deficiency, loss of appetite or just when feel tired, listless or run down in growing children and restores lost vitality after illness. It also helps to maintain healthy skin, hair, nails, teeth and bones.

Dosage and Administration:

| Infants (1-12 Months) | : ½ Teaspoonful/day |
| Child (1-4 Years) | : 1 Teaspoonful/day |
| Child (above 4 Years) | : 1 ½ Teaspoonful/day |
| Adult | : 2 Teaspoonful/day |

Note: Can be taken with water or milk.

Contraindication:

Kvit Seas should not be used in patients on levodopa therapy, hypercalcemia, glucose-6-phosphate dehydrogenase deficiency and hypersensitivity to any of the active ingredients.

Side effects: Very rare.

Drug interactions:

Erythromycin, Conjugated estrogens, Sodium bicarbonate, Chloramphenicol and Chlorothiazide.

Use in pregnancy and lactation:

Should be taken according to advice of physician.

How Supplied:

Kvit Seas 100 ml: Each bottle contains 100 ml syrup with a measuring spoon.

Kvit Seas 200 ml: Each bottle contains 200 ml syrup with a measuring cup.
